REGULATION & DOCUMENTATION MANAGEMENT

CONFLICT MINERALS

Natural resources extracted in a conflict zone and sold to perpetuate the fighting. For example, various armies, rebel groups. and outside actors have profited while contributing to violence and exploitation in the Democratic Republic of the Congo. Commonly mined conflict minerals extracted from the Eastern Congo include cassiterite (for tin), wolframite (for tungsten), coltan (for tantalum), and gold ore. These pass through a variety of intermediaries before being purchased by multinational electronics companies.

RoHS

Restricts certain dangerous substances commonly used in electronics and electronic equipment

- Cadmium (Cd), and Hexavalent chromium (Hex-Cr) levels must be less than 0.01% of the substance by weight at raw homogeneous materials level.
- · Lead (Pb), Polybrominated biphenyls (PBB), Polybrominated diphenyl ethers (PBDE) levels must be no more than 0.1% of the materials by weight at raw homogeneous materials level.
- Mercury (Hg) levels must be 100 ppm or less and must not have been intentionally added.

REACH

Registration, Evaluation, Authorization, and Restriction of

European Union regulation that addresses the production and use of chemical substances and their potential impacts on both health and the environment.

WEEE

Waste Electrical and Electronic Equipment Directive

European Community directive that sets collection, recycling and recovery targets for all types of electrical goods.

DFARS

Defense Federal Acquisition Regulation Supplement

The DFARS for Domestic Specialty

Metals, Alt 1 requires specialty metals be melted in the US or a qualifying country. Qualifying countries can manufacture parts from metal melted anywhere if it meets specifications, but a US company can only use metal melted in the US or a qualifying country. As of this document's date, qualifying countries are Australia, Belgium, Canada, Denmark, Egypt, Germany, France, Greece, Israel, Italy, Luxembourg, Netherlands, Norway, Portugal, Spain, Sweden, Switzerland, Turkey, United

Kingdom, and Northern Island.

SDS, MSDS, OR PSDS

Data Sheet, Product Safety Data Sheet

Procedures for safely handling or working with a substance. Includes physical data (melting point, boiling point, flash point, etc.), toxicity, health effects, first aid, reactivity, storage, disposal, protective equipment, and spill-handling.

ITAR AND EAR

Regulations and Export Administration

United States export control laws that affect the manufacturing, sales and distribution of technology.

NAFTA

North American Free Trade Agreement

Used by Canada, Mexico, Puerto Rico, and the US to determine if imported goods receive reduced or eliminated duty.

COUNTERFEIT PARTS

Detection and avoidance of counterfeit electronic parts.

PPAP

Production Part Approval Process

Automotive supply chain standards verification for component suppliers and their production processes.

PROP65

Proposition 65 (Safe Drinking Water and Toxic Enforcement Act of 1986)

Protects the public from toxic

chemicals in drinking water, exposure to chemicals in products sold in California (CA), and hazards potentially present in CA work environments. The state of CA publishes a list of toxic chemicals that may affect reproductive health, and those known to cause cancer and birth defects. Companies operating or selling in California must notify the public of the presence of these chemicals above the legal thresholds prior to purchase.

TSCA

Toxic Substances Control Act of 1976

Regulates the manufacture, import, distribution, use, and disposal of new and existing chemicals in US commerce to reduce hazardous exposures and environmental pollution. Restricts the use of substances, including asbestos, polychlorinated biphenyls (PCBs). dioxins, radon, metallic mercury lead-based paint, and certain flame retardants.
